The Choosing Justice Initiative (CJI) is seeking a creative individual with a passion for justice, a love of people, strong writing abilities, and experience telling compelling personal narratives for a one-year, part-time Fellowship for our *Gideon 2.0 Project*. Our ideal candidate understands the unfair wealth-based disparities that exist in the criminal legal system, is able to connect easily with people from diverse backgrounds, and has experience/training in producing personal narrative media content.

#### **JOB DESCRIPTION**

# **Core Responsibilities**

- Collect and document personal experiences people have with court-appointed counsel in Nashville, using written narratives, video testimonies, and case materials
- Follow and document court proceedings and case outcomes when people seek to replace judge-selected appointed counsel using CJI's self-help toolkit
- Create compelling media content from the stories and experiences of people with court-appointed lawyers, and publish on various CJI platforms website, social media, digital reports, printed reports, etc.
- Cultivate relationships with Participatory Defense and community organizers to develop successful strategies people who cannot afford to hire counsel can use to access effective legal representation
- Work collaboratively with CJI staff and impacted community members to use the
  compelling personal stories and data captured during the Project to create a final
  report, one that can be used in a public awareness/advocacy campaign for
  meaningful changes to Tennessee's court-appointed counsel system

# Preferred Knowledge, Experience, and/or Skills (one or more)

- Experience using visual, audio, digital, and other media equipment/programs, as well as content editing software (audio and video, post production, graphic design)
- Strong interpersonal skills including the ability to conduct quality interviews, ask effective questions, and develop rapport/trust with story subjects
- Understanding of story fundamentals (effective character, trajectory, hook, authenticity/details, and calls-to-action)
- Background in journalism, publishing, and/or documentary production
- Excellent oral and written communication skills
- Experience repurposing stories across platforms
- Personal experience/interaction with the criminal legal system (i.e., formerly incarcerated/personal involvement in the criminal legal system, or friend/family member to someone who has been incarcerated/involved in criminal legal system

- Knowledge of the complex relationship between poverty and involvement in the criminal legal system, and an understanding of social, institutional, and systemic causes of poverty
- Bilingual (English & Spanish)

### **MINIMUM QUALIFICATIONS**

- Training and experience in creating audio/video/graphic design/print content
- Strong written and verbal communication skills
- A passion for story, narrative structure, and the creative arts
- Ability to devote an average of 30-40 hours/month to the Project for a year
- Reliable transportation and flexible schedule
- Willingness to visit people caged in Tennessee jails/prisons
